

SECOND TRANCHE OF GRUPO ENERGÍA BOGOTÁ S.A. E.S.P INTERNAL PUBLIC DEBT ISSUE

Bogotá D.C., May 19th, 2022. Today, Grupo Energía Bogotá S.A. E.S.P. carried out a bond placement of internal public debt for an amount of up to two hundred and twenty billion Colombian pesos (COP\$220.000.000.000.000) with an overallotment option that allowed to allocate up to four hundred and five billion Colombian pesos (COP\$405,000,000,000,000). Demand was five hundred and eighty-three billion seven hundred and thirty-three million two hundred and eighty-eight thousand three hundred and thirty-five Colombian pesos (COP\$583,733,288,335)¹, which represents 2,65 times the amount offered.

"The resources obtained by Grupo Energía Bogotá for two hundred and sixty-two billion Colombian pesos (COP\$262,000,000,000,000) will be used to finance the Company's Investment Plan, which mainly comprises investments in energy transmission and natural gas infrastructure, contributing to improve the quality of service to citizens and industries. The over-demand from investors, at a time of significant volatility associated mainly with high inflation and interest rates, demonstrates the confidence of investors in the financial strength and long-term projections of Grupo Energía Bogotá", said Jorge Tabares, GEB's CFO. The securities issued have the highest rating (AAA) in the Colombian market assigned by Fitch Ratings.

In compliance with the provisions set in the paragraph 3.2 of article 6.1.1.1.1.5 of Decree 2555 of 2010, the details of the bonds and the placement are indicated below:
