Bogotá D.C., October 25, 2022. Grupo Energía Bogotá S.A. ESP (GEB) informs that its subsidiary, Transportadora de Gas Internacional S.A. ESP (TGI), announced today the result of tender offer in connection with the announced partial cash tender offer for up to **USD\$150,000,000** in aggregate principal amount of its 5.550% Senior Notes due 2028 (CUSIP: 89387Y AC5 (144A) / USP93077AC28 (REG S).

In addition, TGI announced that it has amended the Offer to increase the previously announced maximum tender amount with respect to the Notes from the Maximum Tender Amount to USD\$155,854,000 in aggregate principal amount. Following consummation of the Offer, USD\$594,146,000 aggregate principal of the Notes are expected to remain outstanding.

TGI is a corporation incorporated as a public utility company under the laws of Colombia. As of December 31, 2021, TGI was the largest natural gas transportation company in Colombia, in terms of pipeline asset kilometers, according to the Mining and Energy Planning Unit of Colombia. For the year ended December 31, 2021, TGI delivered approximately 55.9% of the total natural gas transported in Colombia. TGI's pipeline system (the "TGI Pipeline System") consists of nine main pipelines (including secondary branches and loops) with a net transportation capacity of 849.4 MMcfd. The total length of TGI's Gas Pipeline System is approximately 4,033 km.
